**Set-up**: Vendors will be placed in their designated spots Saturday October 30<sup>th</sup> from 9:00am – 4:00pm. *These are the only hours vendors will be able to move in to their space unless other arrangements have been made prior to set-up day.* 

**Removal**: All concessions must be removed no later than 4:00pm Saturday immediately following festival.
